### **Qualifications :**

**Essential :** Bachelor's degree in Agriculture or Master's degree in Botany from a recognised University or equivalent\*.

\*Equivalency certificate issued by the UGC accredited Universities should be attached.

### **Examination Fee & Mode of remittance:**

Rs. 1000/- will be payable as Examination Fee through on-line mode. Details of payment portal will be available in the Online Recruitment Application (ORA) portal. Fee paid by any other mode will not be accepted. Women candidates and candidates belonging to Scheduled Castes (SC), Scheduled Tribes (ST) are exempted

from payment of fee.  
Fee once paid will not be refunded under any circumstances. Duplicate payments, if any, will be refunded after the closing date of submission of application. Request for consideration of such applications and fee payment after the period specified shall not be entertained.

**Place of posting : Anywhere in India**

Candidates must apply online using the Recruitment link in the website [recruitments.rubberboard.org.in](http://recruitments.rubberboard.org.in). Closing date for submission of Online Recruitment Application (ORA) through website is **11.59 PM on 10.03.2025** after which the link will be disabled. Applications received through any other mode will not be accepted, and summarily rejected.

Detailed instructions are provided in the website. Candidates are requested to initially register online using a valid e-mail address and password. Along with application, self attested copies of certificates to prove (i) educational qualification (equivalency certificate, if applicable) (ii) age, (iii) category to avail eligible reservation/relaxation, No Objection Certificate from the present employer in respect of

the candidates employed in Govt. Services/ Autonomous Bodies/Govt. Undertakings are to be uploaded. Applications without required documents will be rejected.

Admit card can be downloaded from the Online Recruitment Application (ORA) website before one week from the date of the exam. SMS alert will be sent to their registered mobile numbers of the applicants. However, candidates should refer the website frequently for updates.

Selected candidates are requested to take a print out of the finally submitted Online Recruitment Application (ORA) and submit the same along with specified documents/certificates in original at the time of joining the service of the Board. The Admit Card duly signed by the Invigilator also needs to be submitted at the time of joining.
